Dear Volunteer Applicant,

Thank you for your interest in volunteering at Mid-Prairie. We appreciate the support we receive from family and community members.

Once you return the completed materials in this application packet, a background check will be conducted. Per School Board Policy, the background check process involves the following databases: Social Security Number Verification & Address History, County Criminal Records Search, Federal Criminal Records Search, National Criminal Database Alias Search & Government Watch List, Sex Offender Records Search, and Iowa Child & Dependent Adult Abuse Registry Information Search.

After the results of the background check are received, any convictions will be compared to the Iowa Board of Educational Examiners (IBOEE) automatic disqualification list for teachers and school administrators. If you have a conviction on this list, you will be automatically disqualified from volunteering at Mid-Prairie.

The Human Resource Coordinator and I will review any convictions not on the IBOEE list. Based on this review, a final determination will be made on your ability to volunteer in the district.

If you are disqualified from volunteering, you will receive a letter by mail. Any volunteer disqualified from volunteering may appeal the disqualification to the Mid-Prairie School Board by completing the appropriate form. The appeal will be heard at a school board meeting open to the public.

The district will pay all costs of the background check process including the \$28.50 fee charged by Third Degree Background Check Screening. The district will gladly accept donations from anyone wanting to help defray this cost.

I want to extend my sincere appreciation for your willingness to volunteer and go through this extensive process. Unfortunately, in today's world, relevant precautions are needed to increase safety for our students.
